

What are crimes against humanity?

“Crimes against humanity” include any of the following acts committed as part of a widespread or systematic attack directed against any civilian population, with knowledge of the attack:

Political & International Unrepresented Negro/Afro Descendant non-Citizen Nationals, of the 1776CE “de jure” & defunct Republic of these united States of America; is an civilian population, exploited by an 1871CE foreign owned corporate municipal federal government, which is legislative & constitutional restricted to the 10 square miles of *District of Columbia*; and not legally allowed to operate upon the Sovereign “de jure” American States of the Republic; but do so under treason, corruption, criminal racketeering; and debt & labor slavery.

- murder;

Unrepresented Negro/Afro Descendant non-Citizen Nationals, have been murdered in systematic attacks, since 1492CE; and 525 years they are still systematic murdered in the streets for statues, regulations, codes, and laws that do not apply to them, for they have Unalienable Rights, and legally are not citizens of states or federal municipal governments; therefore, absent of a common law crime to a municipal citizen/person of flesh and blood; therefore, outside the jurisdictions of these covert and illegal governments.

- extermination;

Unrepresented Negro/Afro Descendant non-Citizen Nationals, which many have an “hidden” aboriginal, indigenous ancestry to the Americas, have been exterminated, since 1492CE; and 525 years they are still exterminated in the streets and incarceration warehouses for statues, regulations, codes, and laws that do not apply to them, for they have Unalienable Rights, and legally are not citizens of states or federal municipal governments; therefore, absent of a common law crime to a municipal citizen/person of flesh and blood; therefore, outside the jurisdictions of these covert and illegal municipal governments.

- enslavement;

Unrepresented Negro/Afro Descendant non-Citizen Nationals, have been enslaved, since 1492CE; and 525 years they are still being enslaved for generations “from cradle to grave”; as debt & labor slaves, called Human Resources, of these covert and illegal municipal governments.

- deportation or forcible transfer of population;

Unrepresented Negro/Afro Descendant non-Citizen Nationals, have been subjugated to deportation of forcible transfer of population from 1492CE – 1865CE

- imprisonment;

Unrepresented Negro/Afro Descendant non-Citizen Nationals, which many have endured imprisonment, since 1492CE; and 525 years they are still imprisoned in the streets and many are held in incarceration warehouses for statues, regulations, codes, and laws that do not apply to them, for they have Unalienable Rights, and legally are not citizens of states or federal municipal governments; therefore, absent of a common law crime to a municipal citizen/person of flesh and blood; therefore, outside the jurisdictions of these covert and illegal municipal governments.

- torture;

Unrepresented Negro/Afro Descendant non-Citizen Nationals, which many have endured imprisonment, since 1492CE; and 525 years they are still imprisoned in the streets and many are held in incarceration warehouses for statues, regulations, codes, and laws that do not apply to them, for they have Unalienable Rights, and legally are not citizens of states or federal municipal governments; therefore, absent of a common law crime to a municipal citizen/person of flesh and blood; therefore, outside the jurisdictions of these covert and illegal municipal governments.

- rape, sexual slavery, enforced prostitution, forced pregnancy, enforced sterilization, or any other form of sexual violence of comparable gravity;

Unrepresented Negro/Afro Descendant non-Citizen Nationals, has, have been, and is being subjugated to rape, sexual slavery, enforced prostitution, forced pregnancy, enforced sterilization, or any other form of sexual violence of comparable gravity from 1492CE – 2015CE, throughout the occupation of Europeans in this Hemisphere.

- persecution against an identifiable group on political, racial, national, ethnic, cultural, religious or gender grounds;

Unrepresented Negro/Afro Descendant non-Citizen Nationals, especially those that know of their Indigenous, Hebrew or Moor ancestry, has, have been, and is being subjugated to persecution political, racial, national, ethnic, cultural, religious or gender grounds

- enforced disappearance of persons;

There are unconfirmed reports that some disenfranchised or homeless Unrepresented Negro/Afro Descendant non-Citizen Nationals are victims of forced disappearances

- the crime of apartheid;

A policy or system of segregation or discrimination on grounds of race.... Unrepresented Negro/Afro Descendant non-Citizen Nationals are victims of apartheid, since 1492CE

- other inhumane acts intentionally of a similar character causing great suffering or serious bodily or mental injury.

Unrepresented Negro/Afro Descendant non-Citizen Nationals and Afro Descendants **(WORLDWIDE) are victims of other inhumane acts intentionally of a similar character causing great suffering or serious bodily or mental injury; for over 500 years, **which has devastated their families and countries where they are a significant number of the population.****
